

# **South Florida Roller Hockey LLC (SFRH)**

## **Complete Combined Liability, Risk, Concussion, Media, Registration & Indemnification Agreement**

---

### **1. Assumption of Risk**

I understand that roller hockey is a high-contact sport involving significant physical activity and inherent risks including, but not limited to collisions with other players, falls, impacts with sticks or balls, high-speed movement, contact with boards or walls, and the possibility of serious injury, including sprains, fractures, concussions, paralysis, or death. These risks may occur even with proper equipment and supervision. I voluntarily assume all risks, both known and unknown, associated with participation in any SFRH activity.

### **2. Release of Liability**

In consideration for being allowed to participate in any program offered by South Florida Roller Hockey LLC (SFRH), the participant (and parent/guardian if applicable) hereby releases, waives, and relinquishes any and all claims for liability, injury, property damage, or wrongful death against SFRH, its directors, officers, coaches, volunteers, staff, sponsors, facility partners, and affiliated parties.

This release applies to all injuries arising out of participation, whether caused by negligence or otherwise, except in cases of gross negligence or intentional misconduct.

### **3. Medical Authorization**

In the event of an injury or emergency, I authorize SFRH staff, coaches, or volunteers to administer basic first aid, seek emergency medical services, and request treatment as needed. I understand that all medical costs incurred are my sole responsibility and will not be covered by SFRH.

---

#### **4. Equipment Responsibility**

It is my responsibility to ensure that the participant wears all required safety equipment, including helmet with cage or shield, gloves, elbow pads, knee pads, shin guards, chest protector, skates, stick, and mouthguard. I understand that SFRH is not responsible for inspecting personal equipment and is not liable for any injuries resulting from equipment misuse, malfunction, or failure.

#### **5. Photo & Video Release**

I grant SFRH permission to photograph, film, or otherwise capture the participant during league activities. I authorize SFRH to use these images or recordings for promotional, instructional, or commercial purposes in any media format. This may include posting on social media, websites, advertising materials, or league communications. I waive any right to inspect, approve, or receive compensation for such use.

---

#### **6. Indemnification**

I agree to defend, indemnify, and hold harmless SFRH and its affiliates against any and all claims, demands, or causes of action arising out of the participant's involvement in roller hockey or related activities. This includes claims brought by the participant, family members, third parties, or other entities.

If any claim, lawsuit, or action is brought against South Florida Roller Hockey LLC (SFRH) in violation of this agreement, the participant and/or parent/guardian agree to indemnify, defend, and reimburse SFRH for all legal fees, attorneys' fees, court costs, settlement costs, and any other expenses incurred in responding to or defending against such claims, to the fullest extent permitted by Florida law.

---

## 7. Concussion Awareness & Management Policy

I understand that concussions are a significant risk in high-contact sports. If a concussion or head injury is suspected, the participant will be immediately removed from play. The participant must sit out for a minimum of 24 hours and may not return until a licensed healthcare provider issues written medical clearance.

SFRH staff cannot diagnose or clear concussions. I understand that SFRH is not liable for concussion-related symptoms, complications, or long-term effects.

## 8. Registration Fee Policy (Non-Refundable)

All registration fees, clinic fees, and program fees paid to SFRH are 100% non-refundable. This includes, but is not limited to:

- Player withdrawal
- Injury or illness
- Schedule conflicts
- Missed clinics or games
- Changes in league schedule
- Weather interruptions
- Facility issues or changes
- Any circumstances beyond SFRH control

Refunds, credits, or transfers are not guaranteed under any circumstances.

---

### 8f. Registration Is Not Complete Until Payment Is Received

Submitting a registration form does not hold or reserve a spot. A participant is **not officially registered** and will **not** be assigned to a team, roster, or clinic until full payment has been received and processed. Spots are confirmed on a **first-paid, first-confirmed** basis.

## 9. Acknowledgment

By signing this agreement, I acknowledge that I have read, understood and agree to all terms and conditions of the *South Florida Roller Hockey LLC (SFRH) Waiver & Release*, including all proceeding sections, whether presented electronically or in PDF Format. I fully understand that by signing, I am giving up substantial legal rights. I sign voluntarily and without coercion, and I agree that this document applies to all SFRH activities for the current season.
